

OFF LICENCE



Licence No: 49D/OFF/201/2020

PURSUANT to the Sale and Supply of Alcohol Act 2012, **Brewwell Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **7 Marion Street also known as 7 Furness Lane, Te Aro, Wellington**, and known as **Garage Project Wild Workshop**, to any person for consumption off the premises and to supply alcohol free, as a sample for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

The licence is subject to the following conditions:

1. Subject to condition 3 alcohol may be sold on or delivered from the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours: **Seven days per week, Monday to Sunday, only between the hours of 12.00 midday and 9:00 pm.**
2. No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
3. A remote sale of alcohol may be made at any time on any day. Any alcohol sold by remote sale must not be delivered at any time between 11pm and 6am the next day.
4. Only "Garage Project" craft beer, cider, and wine or beer imported by "Garage Project" may be sold pursuant to this licence".
5. For any remote sale, the licensee must comply with the requirements in the Sale and Supply of Alcohol Regulations 2013 for signage and to ensure the purchaser is not a minor.
6. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
7. **The whole of the premises is designated as a supervised area.**
8. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
9. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
10. The Licensee must display signage as follows:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. For each principal entrance to the premises, a sign attached to the inside or outside of the premises, so as to be easily read by people immediately outside the premises, stating the ordinary hours of business during which the premises will be open for the sale and supply of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The premises are as set out on the plan submitted with the application and date stamped 21 July 2020 and each principal entrance is shown on that plan.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the renewal, suspension and cancellation of licences, this licence expires on: **4 September 2023**
